Local Law 5 of the year 2024

A Local Law repealing "The Village of Penn Yan Short-term Rental Facilities Moratorium Law of 2023."

Be it enacted by the Village of Penn Yan as follows:

Section 1. Short Title.

This Local Law shall hereafter be known as the "Local Law To Repeal The Village of Penn Yan Short-term Rental Facilities Moratorium Law of 2024".

Section 2. Legislative Findings

The Board of Trustees finds that since the Board has adopted a Local Law amending the short-term rental facilities provisions of the "Zoning" Chapter of the Village Code, which was contemplated by the adoption of the Short-term Rental Facilities Moratorium, such Moratorium is no longer pertinent or necessary and should accordingly be repealed.

Section 3. Legislative Intent and Authority.

The intent of this Local Law is to repeal "The Village of Penn Yan Short-term Rental Facilities Moratorium Law of 2024"

Section 4. Provisions.

The entirety of Local Law 14 of the year of 2023 entitled "The Village of Penn Yan Short-term Rental Facilities Moratorium Law of 2023" is hereby repealed in its entirely.

Section 5. Effective date.

This Local Law shall take effect immediately upon its filing with the Secretary of State of the State of New York, subsequent to having been duly adopted by the Board of Trustees of the Village of Penn Yan.
