## 2021 SIDEWALK IMPROVEMENT PROGRAM (CHAPTER 174, ARTICLE I SECTION 174-6)

### Application Instruction Sheet

1. After receiving the application for sidewalk replacement, fill in all the information possible in the top section only. Do not write in the lower section. Make sure you measure the sidewalk accurately by the foot and enter it in the length and width section provided on the top portion of the application. We do not replace walks from the house to the street. It is important that you leave a number where you can be reached during the day if there are any questions about the application.
2. Read all of the information on the application and print and sign your full name in the space provided. Unsigned applications will not be processed.
3. Once you have completed the application, return it to the Village Office for filing no later than March 12<sup>th</sup>, 2021.
4. The cost for sidewalk replacement for 2021 is \$6.00 per square foot.
5. The application will be processed and you will receive an invoice for your cost on or about March 31<sup>th</sup>, 2021.
6. All payments are due in full no later than April 23<sup>rd</sup>, 2021 unless other arrangements have been made with Village of Penn Yan office personnel.
7. Once the application process has been completed and full payment has been received, the sidewalk replacement will begin on or about April 29<sup>th</sup>, 2021. The order in which the sidewalks to be replaced will be at the discretion of the DPW Street Department.

Any damages to the sidewalk prior to the 28 days will be the responsibility of the property owner. The cost for sidewalk replacement for 2021 is \$6.00 per square foot. The Village is not responsible for the deterioration of new sidewalks due to the use of ice control products.
